Representation Agreement between Black Creek Precision LLC and

Effective as of October 5<sup>th</sup> 2022.

An agreement made this 5<sup>th</sup>, day of October 2022 between Black Creek Precision LLC (hereinafter called the Manufacturer) with an address at 5151 Sunbeam Road Jacksonville FL 32257 USA, of one part and of Gray Wolf Armaments LLC, located at 8050 Beckett Center Dr. Suite 305 West Chester, OH 45069 and Patriam Savuna Sanay Ltd located at Ataturk Mah. Atasehir Blv No. 17 Ata Plaza 3/3 K:1 D:13 34758 Atasehir, Istanbul, Turkey (hereinafter called the Representatives) of the other part witness as follows:

1. Effective August 22<sup>nd</sup>, 2022, and at no time earlier, the Manufacturer hereby appoints Gray Wolf Armaments LLC & Patriam Savuna Sanay Ltd as its non-exclusive Representatives to make enquiries within the Republic of Turkey in regards to the sale of Military weapons and rifles, military rifle parts, grenade launchers, pistols, ammunition manufacturing facilities, weapons armories, sporting and hunting shotguns and rifles, military night vision, and military ammunition, and military support equipment where applicable and legal pursuant the Arms Export Control Act and the International Traffic in Arms Regulations (ITAR); The Representatives shall have the non-exclusive right for a period of twenty four (24) months, or longer if permissible by the Manufacturer, to make enquiries as to the sale of these listed military products to be sold in the Republic of Turkey following the date of October 5<sup>th</sup> 2022, and other nations as mutually agreed upon in writing by the parties to this Agreement.
2. The Manufacturer and the Representatives shall agree to engage in further talks to define their mutual relationship with regards to other territories and other products as future conditions may warrant.
3. The Representatives shall carry out all required marketing activities within their own territory from their own resources. However, templates and proper marketing copy to this effect shall be provided by the Manufacturer, in the English language. The Representatives shall bear the cost of translation and printing as needed for use in their permitted territory.
4. The contract is valid for twenty four (24) months from the date of signing of contract and may be extendable with the mutual consent of both parties.
5. Venue for any litigation, legal action or other proceeding brought for the enforcement of this Agreement, or because of an alleged dispute, breach, default or misrepresentation in


